DANIEL: A tract on Appalachee River in Jackson County, granted to Edmond Daniel, was sold by William Melton of Greene County, Ga., to Alexander Awtry of Jackson Dec. 20, 1797, and a deed recorded in Greene County 1798 and in Jackson County 1799, recited that on May 23, 1797, William and wife Lucy Melton of Greene County conveyed to Solomon Burford and heirs and to William Daniel and wife Polly (Mary Kemp) of Greene County, Jackson County land. One William Daniel, perhaps the same, was listed in the 1805 Jackson lottery. Edmond appears in the Wilkes County records from 1785. One William Daniel married in Greene County March 9, 1789 Mary King (Kemp?) and one William left a will there prior to 1820 when Hannah, James, James K., Mary, Polly, Samuel and William were enumerated in Greene. Among others in the state 1820 were Allen and Russell of Madison County; Ephraim, Isaac and Pendexter of Walton County; and James, Jeremiah, Josiah, and William Daniell of Clarke County. Allen Daniel Sr., a Revolutionary soldier, was born 1738 in Virginia, and died in Madison County, 1814, having previously lived in Elbert County. He married Mary Allen and had children Elizabeth (married Aaron Johnson), Allen Jr. (born in Virginia 1772, married Mary, daughter of Russell Jones, served in the War of 1812, died 1836), James (married Elizabeth, daughter of James Jones, and second, Delilah Eunice Wilson) and Charity (married Elisha Johnson.) Allen appears in the Wilkes County records as early as 1788. In 1789, William Allen bought land on Beaverdam Creek from William and Nancy Daniel, with Allen Daniel as a witness. Several other Daniels in Georgia were Revolutionary soldiers, including William of Clarke County, born in North Carolina 1743, died 1840. Among the hundreds of Daniels in Georgia in the 1820s, Littleton was enumerated 1820 in Washington County (as were several others); in 1827, he was in Gwinnett County, and Littleton Jr. was in DeKalb County. In 1832, Littleton, a Revolutionary soldier, was living in Heard County; he drew Cherokee County land granted Dec. 15, 1835. Among others in 1830, John and John M. Daniel were enumerated in DeKalb County, and Reuben in Gwinnett County. This name is found in Greenville District, S. C., 1790-1800 and previously in Orange County, Va., as early as 1760, and in Henry County, Va., c1784.

99. DEAL: James and William were in Jackson County by 1804, were listed in the 1805 lottery, obtained headright land in 1806, and James in 1807 was living in Cochran's Mulberry Fork district. John Deal is found in Jackson County c1810. In 1820, William was enumerated in Habersham County, and William's orphans were in Henry County, Ga., in 1827. One William was in the Wilkes County tax list of 1785, and William Sr. and Jr. were enumerated 1790 in Abbeville District, S. C. James Diol was in Greenville District, S. C., in 1800 and John Dial in DeKalb County, Ga., in 1830. In Charlotte County, Va., 1786, Daniel Dial married Patsy, daughter of William Pentecost, a family later represented in Jackson County.
